NOW COMES Respondent North Carolina Department of Transportation, by and through counsel, moving to dismiss this matter as follows:

MOTION TO DISMISS

Respondent North Carolina Department of Transportation (NCDOT) moves to dismiss this matter as to all named respondents for lack of subject matter jurisdiction, pursuant to the North Carolina Rules of Civil Procedure and Chapter 150B of the General Statutes.

Petitioner seeks judicial review of a final agency decision pursuant to N.C.G.S. § 150B-43, et seq. Under N.C.G.S. § 150B-51(d), this Court is expressly permitted to enter "any order allowed by G.S. 1A-1, Rule 12(c) or Rule 56" since Petitioner's petition was dismissed for lack of subject matter jurisdiction by Administrative Law Judge J. Randall May.

Neither Respondent NCDOT nor the other respondents named by Petitioner are subject to jurisdiction under the contested case provisions of Chapter 150B. First, NCDOT is expressly exempted from these provisions by N.C.G.S. § 150B-1(e)(8) "except as provided in G.S. 136-29" (which does not apply in this case). Moreover, no local unit of government or independent State contractor is covered by Chapter 150B. See N.C.G.S. § 150B-2(1a). Thus, there is no jurisdiction over Respondents Town of Dallas, N.C. or North Carolina Motor Vehicle License Plate Agency in Gastonia, N.C.

Because there is no subject matter jurisdiction over respondents under the contested case provisions of Chapter 150B, this Court similarly cannot exercise jurisdiction over respondents upon Petitioner's appeal. Accordingly, Respondent respectfully requests this Court dismiss this matter with

prejudice as to all parties pursuant to Civil Procedure Rules 12(b)(1) and 12(c).

WHEREFORE, Respondent prays to the Court:

- 1. That this matter be dismissed with prejudice as to all respondents.
- 2. That all costs be taxed against Petitioner.
