**AFFIDAVIT  
OF

**In submitting this Affidavit for Appearance Before the Grand and/or Petit Jury**

AFFIANT, Thomas Scott Dunn, of lawful age, not a member of the Armed Services of this Nation, and does hereby declare his background history as assurance to the Affiant's creditability and competence for entrance into any Court of Law or Equity for purpose of presenting evidence and testimony pursuant to 18 USCA s 4, --- and/or entering as Amicus Curiea in these matters of **collusion** within the U.S. Court, herein, described within the criminal complaints now brought.

1. Affiant, Thomas S. Dunn, recruited into N.S.A.'s (National Security Agency's) A.S.A. (Army Security Agency), Far East, as field agent with 330th A.S.A., wherein, Affiant was head of Top-Secret- Codeword operations as Non-Commissioned-Officer-In-Charge (RA 13-516-178); and,
2. that, Affiant, Thomas S. Dunn, after departure from ASA, became a member of the Baltimore P. D. for purpose of financing education, until injured-line-of duty, retired and pensioned; and,
3. that, during service with Balto. P.D. Affiant was assigned to stake-out unit, commercial hold-ups & industrial burglaries, which entailed apprehensions, investigations, and testimony before the Baltimore Grand Jury and the Criminal Court of Baltimore; and,
4. that, Affiant relocated from Baltimore to Albion, Maine, after retirement from B.P.D., at which time Affiant was requested to become president/investigator for L.A.W., Inc., a citizen's advocate organization that exposed corruption at all levels, and which was extremely successful.
5. Affiant, Thomas Scott Dunn, declares under penalty of perjury pursuant to the laws of the State of Arizona that the foregoing is true and correct, and that this affidavit was executed this 19<sup>th</sup> day of September, 2005, at Congress, County of Yavapai, State of Arizona.
6. Further, Affiant sayeth naught.

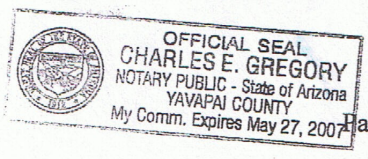
