Dear Attorney General Foster,

In 2006 I hand delivered documents to the Attorney General's Office requesting a full and fair investigation into the cover up of the death, a homicide, in Farmington.

Those of us who filed complaints with the Farmington, P.D. and met with Corporal Scott Ferguson got the impression from Corp. Ferguson that this investigation would be compromised. It would later come to light that he did compromise this case, did not investigate this case and provided false statements to then Attorney General Kelly Ayotte.

This case involves the cover up by law enforcement agencies/officials in New Hampshire including, but not limited to, failure of the Department of Human Services, Bureau of Elder Services, to protect and uphold Elder Abuse Laws, failure of law enforcement and DHS to protect and uphold Americans with Disabilities Act, theft by deception and the filing of a fraudulent Certificate of Death. Law enforcement officers/officials have breached the tenets of their sworn oaths of office and have obstructed justice.

Outlined is what demands investigation, indictment and prosecution:

- Homicide; cover up
- Theft By Deception
- Interstate transportation of stolen property
- Official Corruption
- Obstruction of justice, abuse of discretion and malfeasance of office by New Hampshire law enforcement/officials/agencies
- Violations of Elder Abuse Laws and the Americans with Disabilities Act by Department of Human Services
- False swearing on an official document

I contacted Tracy M. Culberson, the Elder Abuse and Financial Exploitation Unit, for a full and fair investigation into this very serious matter. I learned that Culberson spoke with only the perpetrators who have aided and abetted/shielded this criminal matter.

On September 7, 2006 I received a telephone call from James Brown, Investigator in the A.G.'s Office, informing me that he was the investigator assigned to this case. I am requesting Investigator James Brown's investigative report **regarding his interviews** with my witnesses, including eye witnesses.

I am also requesting a meeting with you to present documented evidence of the crimes committed in this case.

New Hampshire Bill of Rights at Article 35, Part First of the New Hampshire Constitution provides that it is essential to the preservation of the rights of every individual, his life, liberty, property, and character, that there be an impartial interpretation of the laws, and administration of justice.

Pursuant to **Title I 7:6 and 21-M:5 Powers and Duties as State's Attorney.** – the attorney general shall enforce the criminal laws of the state; he shall: I. represent the public interest in the administration of the department of justice and be responsible to the governor, the general court, and the public for such administration.

Pursuant to **7:8-a Division of Public Protection.** – There is hereby established within the office of the attorney general a division of public protection and **21-M:2 and 21-M:8** establish that the department of justice shall supervise and conduct criminal investigations and prosecutions.


RSA 640:2II(a) "Public servant" means any officer or employee of the state or any political subdivision thereof, including judges, legislators, consultants, jurors, and persons otherwise performing a governmental function.

Public servants have breached the tenants of their sworn oaths of office, fiduciary duties and the public's trust, including violating the American With Disabilities Act, and the Adult Protection Statute, RSA 161-F:42-57 which mandates the reporting of elder abuse. The Department of Health and Human Services, Division of Elderly and Adult Services (DEAS), charged with the responsibility to carry out the requirements of the law, failed miserably and could have prevented a death. The DHHS acts or omissions are result of gross negligence or willful misconduct and demand investigation.

Pursuant to **173-B:9 Protection by Peace Officers**, as defined in RSA 173-B:1, that officer shall use all means within reason to prevent further abuse. My documented evidence, along with my witnesses' statements, will prove the obstruction of justice, undue influence and cover up by local, county and state law enforcement agencies.

I appreciate your assistance and cooperation in this matter and look forward to a date and time in which to meet with you. Please send me James Brown's investigative report **regarding his interviews** with my witnesses, including eye witnesses.
